1. Introduction

Welcome to the Matrix-Q Guild, an initiative by the Matrix-Q Ecosystem developed and led by Luis Daniel Maldonado Fonken. These Terms of Service govern your participation in, access to, and interactions with the Matrix-Q Guild—whether you are a formal Guild Member, trial participant, applicant, or general participant in our ecosystem.

By engaging with the Matrix-Q Guild in any capacity, you agree to abide by the following terms and conditions.

2. Definitions

“Guild” refers to the Matrix-Q Guild, its gamified programs, activities, and services.

“Member” means a formally accepted participant in the Guild.

“Non-Member” includes applicants, trial participants, workshop attendees, or anyone engaging without full membership.

“Ecosystem” refers to all activities, organizations, platforms, and communities led by or affiliated with Luis Daniel Maldonado Fonken and Matrix-Q Research Institute, as for the daughter companies, MQ9 Matrix-Quotient 9 Solutions BV, MQC Matrix-Quitent Circular Solutions BV, Stichting Luis Daniel Maldonado Fonken, Matrix-Q Akademia, Studio, Temple, Expeditions, Innovation Lab, Fund, and other divisions

“We/Us” refers to Matrix-Q Guild and the Ecosystem team.

3. Eligibility and Application

All applicants must be at least 18 years old.

Submission of a motivation letter is mandatory for application.

Acceptance into the Guild is subject to review and non-discriminatory, but based on alignment with the Guild’s mission, values, and purpose.

We reserve the right to deny or revoke membership or access at any time due to violation of these terms, misalignment with values, or harmful behavior.

4. Free Discovery & Trial Participation

Free consultations, discovery sessions, or trial program invitations do not constitute automatic Guild membership.

Trial participants are expected to engage respectfully and follow Guild guidelines.

Participation in a trial does not guarantee acceptance as a full member.

5. Guild Member Responsibilities

By becoming a member, you agree to:

Engage respectfully and constructively with other members and the leadership team.

Abide by the Gamification Code of Conduct, including fair play, honesty in point-earning, and non-manipulative behavior.

Uphold the values of purpose-driven innovation, collaboration, holistic growth, and community well-being.

Complete the task, missions, projects, challenges, campaigns, training and coaching programs assigned

Protect all confidential or proprietary content, practices, or materials you access through the Guild.

6. Code of Conduct

Whether member or non-member, all participants must:

Foster a safe, inclusive, and growth-oriented environment.

Refrain from hate speech, harassment, discrimination, or disruptive behavior.

Respect intellectual property and refrain from sharing or copying content without permission.

Follow Matrix-Q's Ethical Principles, including respect for nature, humans, and the collective mission.

7. Content, IP & Confidentiality

All content, training materials, frameworks, and designs shared within the Guild, including their derivatives, are the intellectual property of Luis Daniel Maldonado Fonken and/or Matrix-Q Research Institute unless otherwise stated.

10. Financial Transactions & Marketplace

The Matrix-Q Akademia, under specific conditions, may convert the Matrix-Q Guild points into credits for coaching and training programs

Purchases of services, coaching, or products from the Guild Marketplace are bound by the terms and policies of the individual provider in agreement with the Matrix-Q Ecosystem and its standards.

11. Suspension or Termination

We reserve the right to suspend or terminate access to the Guild or any of its platforms, programs, or services, for reasons including but not limited to:

Breach of these Terms

Disruptive behavior or misconduct

Inactivity or disinterest over extended periods (as defined by internal review)

Misuse of proprietary tools, content, or brand

12. Solopreneurship Alignment, Access to Intellectual Property, and Commercialization Rights

12.1 Guild Members as Solopreneurs & Commercial Engagement

All official members of the Matrix-Q Guild are considered solopreneurs, whether they are in the early stages of their journey or actively involved in commercial activity. Membership implies a clear motivation to:

Acquire commercial content and tools

Engage in the co-creation and strategic use of intellectual property (IP) within the ecosystem

Participate in commercialization processes and opportunities in alignment with Matrix-Q vision and principles

Guild members agree to operate under the Matrix-Q Ecosystem's regulatory frameworks, including:

16.2 Non-Members & Access to Non-Commercial Training

Individuals who participate in Matrix-Q activities without becoming members of the Guild will receive access to non-commercial training and coaching only. This includes, but is not limited to, introductory workshops, community events, presentations, discovery sessions, and promotional educational content.

Intellectual Property shared with non-members:

Will be designated as non-commercial content or community-benefit educational material, with no resale or licensing rights

Cannot be used for commercial or branding purposes without explicit, written authorization

Will not provide access to the Licensing, Certification, or Gamification Systems, which are reserved for qualified Guild members only

Non-members and Members who wish to gain commercial access or participate in IP co-creation must apply for Guild membership, and be eligible to sign the appropriate solopreneurship agreements.

12.3 IP Clearance Levels, Role, Rank & Expertise Access

The Matrix-Q Guild utilizes an IP clearance system that determines each member's access to specific content, tools, training, and commercialization opportunities. This system ensures ethical use, alignment with purpose, and effective ecosystem collaboration.

Access is granted based on:

The member's Role (e.g., Learner, Facilitator, Innovator, Partner, Co-Creator)

Their Rank and accumulated Points within the Guild's gamified framework

Their alignment with the Matrix-Q Ecosystem vision, ethics, and regenerative principles

Their certified level of expertise within any Matrix-Q Methodology or Innovation Path

Their agreement to and active participation in the Solopreneurship Track, including business engagement, co-creation, and impact-oriented contributions

12.4 Knowledge acquisition only

Members who wish to engage only in knowledge acquisition without business involvement will have specific and limited access to non-commercial or specialized content designed for self-development. They are not permitted to receive IP, methodologies, or strategies designated for commercial use unless they later opt-in to the solopreneurship pathway and sign the required agreements.
